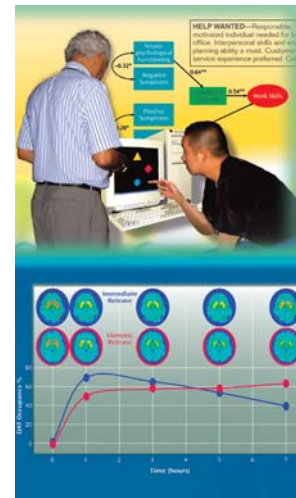

Assessment of effective treatment involves analysis of physiological and psychosocial outcomes, both of which are the focus of articles featured in this issue. Psychosocial outcomes, as portrayed in the top image, were studied by Bowie et al. (p.418) who examined adaptive life skills impairment among individuals with schizophrenia and found that an individual's neurocognitive skills were related to work and interpersonal relationships, but the relationship is indirect and mediated by functional capacity. Of course, functional capacity alone may not be enough to overcome barriers to employment for people with schizophrenia, as Rosenheck et al. (p.411) report from data collected for the CATIE study. Physiological outcomes, as portrayed in the bottom image, were studied by Spencer et al. (p.387) who used PET imaging to compare the abuse potential and mechanism of two stimulant formulations.
