Smoking and Schizophrenia in Population Cohorts of Swedish Women and Men: A Prospective Co-Relative Control Study

Smoking predicted increased risk for later schizophrenia in female and male population cohorts. In monozygotic twins discordant for smoking, the smoking twin had a higher risk for nonaffective psychosis.

Molecular Mechanisms and Timing of Cortical Immune Activation in Schizophrenia

Immune activation in the prefrontal cortex in schizophrenia is indicated by high mRNA levels for IFITM, a viral restriction factor. Levels were also high for cytokines that induce IFITM expression and for a critical transcription factor; levels were low for a transcriptional inhibitor. Similar levels were found in adult mice given an immune stimulant, but not those with prenatal exposure to maternal stimulation.
