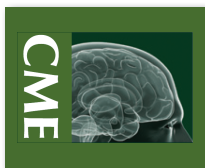

Neural Correlates of the Propensity for Retaliatory Behavior in Youths With Disruptive Behavior Disorders

Youth with disruptive behavior disorders (DBD) and low levels of callous-unemotional traits show greater increases in activation of neural threat circuitry when punishing others, relative to healthy youths and to patients with DBD and high levels of callous-unemotional traits. They also have dysfunctional down-regulation of the ventromedial prefrontal cortex during retaliation.

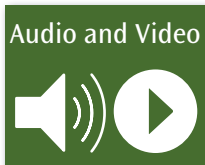
Reproductive Safety of Second-Generation Antipsychotics: Current Data From the Massachusetts General Hospital National Pregnancy Registry for Atypical Antipsychotics

Registry data on 303 pregnant women indicate that the rate of major malformations among infants exposed to second-generation antipsychotics (1.4%) is not significantly higher than the rate among unexposed infants of mothers with psychiatric illness (1.1%).
