# Mortality and Cumulative Exposure to Antipsychotics, Antidepressants, and Benzodiazepines in Patients With Schizophrenia: An Observational Follow-Up Study

Both moderate and high levels of antipsychotic exposure were associated with substantially lower overall mortality rates, compared with no exposure, in patients with schizophrenia. Moderate and high antidepressant exposure levels were also associated with lower mortality rates in schizophrenia patients, but exposure to benzodiazepines showed a dose-response relationship with mortality.

# Effect of Hippocampal and Amygdala Connectivity on the Relationship Between Preschool Poverty and School-Age Depression

Severity of negative mood or depression in school-age children was predicted by greater preschool poverty and by current connectivity between the left hippocampus and right superior frontal cortex and between the right amygdala and right lingual gyrus. Connectivity mediated the relationship between preschool poverty and negative mood/depression.

Menolascino, of the University of Nebraska College of Medicine, reports findings on more than 600 children who presented over a 5-year period to the Mental Retardation Clinical Evaluation Unit, concluding, "The child psychiatrist is in an ideal position to employ the present clinical and theoretical bodies of knowledge concerning the psychosocial factors that can produce mental retardation, and formulate meaningful programs of treatment and prevention."
