

BioMEND (Bioelectronic Medicine for Neuropsychiatric Disorders) Research Fellowship

The Zucker Hillside Hospital
Hofstra Northwell School of Medicine

Neuromodulatory approaches including TMS (Transcranial Magnetic Stimulation), tDCS (transcranial Direct Current Stimulation), DBS (Deep Brain Stimulation) as well as ECT (Electroconvulsive Therapy) are gaining increased clinical and research attention in the treatment of severe mental illness. The Zucker Hillside Hospital has recently established the BioMEND (Bioelectronic Medicine for Neuropsychiatric Disorders) Center to conduct cutting edge clinical, and research work focused on these non-pharmacological treatment strategies.

A combined BioMEND Clinical and Research Fellowship is now available beginning July 1, 2018 for individuals interested in attaining expertise in this rapidly developing field. The Zucker Hillside Hospital is currently the clinical center for more than 6000 treatments/year with ECT, TMS and tDCS and is conducting a number of research studies focused on the interindividual variation in response to ECT, TMS and tDCS treatment. Our multidisciplinary team provides comprehensive research opportunities in understanding the underlying neurobiology behind these approaches. Research approaches include basic clinical and neurocognitive studies, EEG and neuroimaging measures, as well as more invasive techniques using iEEG (intracranial EEG) and ECeG (Electrocorticography) in human subjects. Fellows will have the opportunity to gain clinical expertise with these modalities as well as to conduct innovative clinical, neurophysiological and neuroimaging research. We offer education and hands-on involvement in all phases of research design, implementation, data analysis, grant writing, and publication. Fellows must have completed a psychiatry residency.


