Improving the Efficiency of Psychotherapy for Depression: Computer-Assisted Versus Standard CBT

Cognitive-behavioral therapy (CBT) using an Internet program plus 12 therapist sessions for depression has a remission rate similar to that for standard CBT. Improvements are maintained at 6 months.

Impact of SSRI Therapy on Risk of Conversion From Mild Cognitive Impairment to Alzheimer's Dementia in Individuals With Previous Depression

Patients with mild cognitive impairment who have a prior history of depression and long-term SSRI treatment have a 3-year delayed progression to Alzheimer's dementia relative to those with prior depression and short-term SSRI treatment, treatment with other antidepressants, or no treatment and relative to patients with mild cognitive impairment without a history of depression.
