
Revisit the field's rich history through the AJP Archive

75 years ago this month: Problems Confronting Psychiatry in the Army Convalescent Hospital

Brigadier General William C. Menninger, co-founder of the clinic that bears the family name, discusses a presentation by a member of the Operations Service of the Surgeon General's Office that outlined the neuropsychiatric problems of the Army (and which appeared in the same issue). Menninger outlines how these problems the Army faced at war's onset were addressed over the course of the conflict, concluding "we in psychiatry have had a closer, happier relationship with all other specialties of medicine than in any situation in civilian life. There is not a general medical officer in the Army who has not had more exposure to psychiatric problems in his Army career than he did in all the rest of his medical career put together. We only hope that he and his future patients will profit from it."
