

Comment: The principal diagnosis was a psychiatric disorder for most of the patients (n=3725, 85%). Of these patients, 3230 (87%) had only one principal diagnosis. For patients with multiple stays, principal diagnoses diverged, with 2 principal diagnoses for 449 patients and 3 principal diagnoses for 46 patients. The main diverging diagnoses were psychotic disorders (F20-F29), where personality disorders (F60-F69) were diagnosed for 101 patients, anxiety disorders (F40-F48) with personality disorders (F60-F69) for 90 patients, mood disorders (F30-F39) with personality disorders (F60-F69) for 73 patients, mood disorders (F30-F39) with anxiety disorders (F40-F48) for 66 patients and psychotic disorders (F20-F29) with anxiety disorders (F40-F48) for 65 patients. Among patients with no psychiatric diagnosis, 25% (n=167) had no diagnosis noted at all, 33% (n=222) had ICD-10 code Z651 *"Problems related to other psychosocial circumstances (Imprisonment and other incarceration)"*, 22% (n=146) had ICD-10 code Z004 *"General psychiatric examination, not elsewhere classified"*, and 20% (n=132) had another ICD-10 code.
