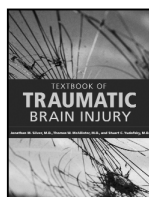


This book describes a new technology that allows physicians to focally stimulate the brain in awake adults through a non-invasive procedure.

Transcranial Magnetic Stimulation in Clinical Psychiatry is an accessible and authoritative review of TMS, a procedure that is showing promise as a treatment in several disorders. Its authors explain how the procedure works, then the latest findings in a wide range of situations—notably in depression, but also in other conditions ranging from migraine to stroke recovery.

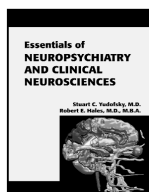

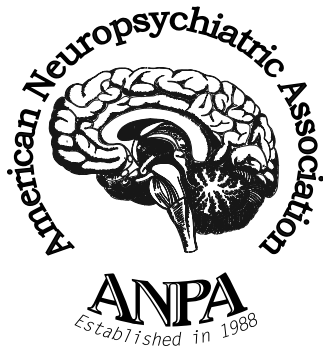

Call for Abstracts

We are pleased to announce the 19th Annual Meeting of the American Neuropsychiatric Association to be held in Savannah, Georgia at the Marriott Savannah Riverfront, March 1 - 4, 2008. This year's meeting will include a Keynote Address and several scientific sessions, each with several prominent speakers. The meeting will also include a Poster Session with concurrent Hot Topics Platform Presentations, offering an opportunity to present new research and to discuss the work of others. We invite you to submit an abstract of your research to be presented during this session.

Travel awards will be given to several of the young investigators who are embarking on promising careers in the clinical neurosciences. The ANPA Scientific Program Committee will review all abstracts, and decisions regarding acceptance will be e-mailed at the end of November.

On-line abstract submission will be available beginning May 1, 2007. The absolute deadline for the receipt of abstracts is October 22, 2007. Abstracts accepted and presented at the meeting will be published in the spring 2008 issue of the *Journal of Neuropsychiatry and Clinical Neurosciences*, the official journal of ANPA. **Please note that by submitting an abstract, the investigator agrees to attend the meeting and present the poster or to designate an alternate presenter who will attend the meeting.**

Abstract Submission Instructions

Abstracts must:

- Adhere to the format in order to be considered.
- Have relevance for neuropsychiatry, behavioral/cognitive neurology, or the clinical neurosciences.
- Represent work not previously published or presented.
- Be 250 words or fewer (not including title, authors, and affiliations).
- Be clearly and concisely written and contain sufficient information to allow the review committee to assess the research being presented.
- Include affiliation for principal or first author only.
- List the e-mail address in the submission that can be used for all communication.
- Be sure to list all authors in the abstract.
- Include a list of all external sources of support and possible conflicts of interest.

Format:

- Please type your title as follows: The First Letter of Each Word is Capitalized, Except for the First Letter of Each Preposition or Conjunction.
- Scientific words can be entered in mixed case (e.g. fMRI).
- Tables, photographs, figures, or references may not be included.
- All submissions must be in a Word or text document.

In addition, strict adherence to the formatting listed below for either Original Work or a Case Report is required. Abstracts that do not follow the formatting requirements will not be reviewed.

Format for Original Work

- Background:** A succinct summary of the literature or theoretical rationale underlying the abstract.
Example: HIV-Associated Dementia (or AIDS Dementia Complex) is thought to represent a subcortical dementia with...
- Objective:** This section should provide the basic rationale for the research and the hypothesis tested.
- Methods:** This section must include the number of subjects and information about the experimental design.
Example: Subjects included 20 HIV-seropositive male outpatients who met criteria for HIV-Associated Dementia. All subjects received...
- Results:** This section should include the statistical approach and details of the analysis (including statistical or experimental controls) that support the conclusions. Statements such as “results will be discussed” or “data will be presented” are not acceptable.
Example: Apathy measures were significantly correlated with basal ganglia hypoperfusion. This is in contrast to...
- Conclusion:** This section should summarize the essential findings and their implications
Example: Apathy, but not syndromal depression, is associated with subcortical impairments in...

Format for Case Report

Background: A succinct summary of the literature or theoretical rationale underlying the abstract.

Case History

Conclusions: This section should summarize the essential findings and their implications

General Information

Abstracts will be reviewed by the ANPA Program Committee. The decision of the Committee is final. The on-line submission deadline is: **October 22, 2007**. Instructions for on-line abstract submission will be posted on the ANPA web site: www.anpaonline.org beginning **May 1, 2007**. Notifications of acceptance / rejection will be e-mailed in late November. Please register for the meeting when you submit your abstract. On-line registration: www.anpaonline.org

Young Investigator Awards

Travel awards will be given to several young investigators who are embarking on promising careers in the clinical neurosciences. These young investigators will be chosen from among the abstract presenters. To qualify for the Young Investigator Award, the applicant must have performed the work described in the abstract while in training. The applicant's training director must provide a letter confirming that the work was performed during training. We do not request letters of reference. The investigator must also provide a curriculum vitae and a statement of between 250 and 1000 words. The statement should describe the submitter's role in the research; training background; interest in neuropsychiatry, behavioral and cognitive neurology, or the clinical neurosciences; and plans for his or her career. The Awards Committee will choose recipients based on the quality of the abstract and, more broadly, the candidate's perceived ability to make a contribution to the field with the encouragement and support provided by the award. Applicants for the Young Investigator Award, like others who submit abstracts, are agreeing to present the work if the abstract is accepted, regardless of whether a Young Investigator Award is granted. Award winners must attend the entire meeting. The Committee's decision is final.

To apply: Submit the information listed above to ANPA office. The deadline for receipt of all application materials is October 22, 2007.

The American Neuropsychiatric Association (ANPA), established in 1988, is an organization of professionals in neuropsychiatry and the clinical neurosciences. Our mission is to apply neuroscience for the benefit of people. We work together in a collegial fashion to advance knowledge of brain-behavior relations, provide a forum for learning, and promote excellent, scientific and compassionate care.

The strength of the organization is our diversity of membership, which is comprised of professionals in neuropsychiatry, behavioral neurology, neuropsychology, neuroradiology, neuropathology, and neurosurgery as well as the basic neurosciences, who share clinical and/or academic interests in neuropsychiatry. The interdisciplinary nature of the membership encourages collaborations among educators, clinicians, researchers, students and trainees in research presentations, symposia, workshops and/or continuing education courses. Students, fellows and other trainees are encouraged to participate and are offered discount membership and conference fees. The *Journal of Neuropsychiatry and Clinical Neurosciences (JNP)* is the official publication of the organization, and is a benefit of membership.

ANPA holds its annual scientific meeting in the early spring, and provides up to 30 CME / CE credits. Joint meetings with the International Neuropsychological Society, the British Neuropsychiatry Association, and the International Neuropsychiatry Congresses have added an international dimension to the ANPA conferences. Members are encouraged to submit their work for presentation at these annual meetings. Travel awards are available for promising young investigators. Annual meeting abstracts and proceedings are published in *JNP*.

In 1999 the designation of Fellow of the American Neuropsychiatric Association was established in recognition of special achievement in neuropsychiatry, behavioral neurology, neuropsychology or the clinical neurosciences.

In 2001 the ANPA Career Development Award Program was instituted. It recognizes advanced trainees in psychiatry, neurology, or neuropsychology whose accomplishments during training offer promise of a successful career in neuropsychiatry and the clinical neurosciences. The award will support costs associated with participation in two consecutive Annual Meetings, establish an informal mentoring relationship between the awardee and one ANPA Fellow and facilitate the awardee's involvement in ANPA.

ANPA has been actively engaged in efforts toward creation of subspecialty certification for neuropsychiatry including developing a core curriculum and guidelines for training in neuropsychiatry. In March 2004, a joint application from ANPA and the Society for Behavioral and Cognitive Neurology (SBCN) was submitted to the Unified Council for Neurologic Subspecialties (UCNS) for recognition of the Neurological Subspecialty Area (NSA) of Behavioral Neurology & Neuropsychiatry (www.ucns.org). On June 30, 2004 Behavioral Neurology & Neuropsychiatry was approved as a single subspecialty. The first certification exam in Behavioral Neurology & Neuropsychiatry took place in September 2006.

This fourth edition features a number of significant enhancements.

- Coverage of dementia has been expanded to reflect the disorder's increasing incidence, especially in Alzheimer's disease and cerebrovascular illness.
- Material on substance abuse disorders is organized so that problems with individual drugs and certain common treatment modalities are given separate chapters, with sections within each chapter written by separate authors who are experts on that particular topic.
- The chapters on personality disorders reflect important recent advances: longitudinal research showing that such disorders undergo substantial improvements; the growing recognition that personality disorders have significant genetic determination; and the manualization of psychoanalytic psychotherapy to permit testing and replication.
- Coverage of schizophrenia reflects research of the past decade demonstrating the importance of the cognitive characteristics and sequelae of the illness and outlining the domains and molecular targets of intervention.
- The section on eating disorders has been streamlined to four chapters covering intensive treatments, psychopharmacological treatment, evidence-based and innovative psychological treatments, and family and marital therapy.

Gabbard's Treatments of Psychiatric Disorders is an essential touchstone for practitioners and an outstanding reference for students in the mental health professions. Particular care in streamlining its revision has helped make this fourth edition an even more useful clinical tool for day-to-day practice.
