

The United Council for Neurologic Subspecialties (UCNS) will be offering the third certification examination in Behavioral Neurology & Neuropsychiatry (BN&NP). The certification examination will be held on **November 10–14, 2008**. The deadline to apply for the examination is **May 15, 2008**.

The certification examination will last for 4 hours and will consist of 200 computerized multiple choice questions. Pearson VUE will administer the examination at Pearson Professional Centers across the United States. Candidates will have the option of choosing one of the five days to sit for the examination and will be able to select a location to minimize travel, if necessary.
