I have always painted. After getting my MRCPsych I went to Byam Shaw Art School and then came back to psychiatry. I worked in Camden and specialised in rehabilitation.

Things really took off when I started making colour etchings 5 years ago. All of my etchings are about people. A Drink is a four-plate colour etching. The night after I had printed the edition I woke up thinking 'what I have I done'? It is the only print that I made that is not sympathetic. I did not like the man. But people like the etching and it has sold well. People smile



when they see it: my framer said, 'I have some shorts like that'. I realised that empathy is not necessarily about sympathy but more the process of feeling what the other person feels: sometimes unconsciously.
